

# Spiritual Participation & Sankalp Program

#### 1. Program Overview

- 'Divyatra' is a collective spiritual initiative for Hanuman Chalisa recitation and Sankalp rituals.
- All contributions are voluntary and used solely for devotional purposes.

## 2. Registration & Referral System

- A participant may refer up to 2 individuals per week.
- Participants have a maximum of 30 days to complete 6 free referrals.
- Each cycle of promotional bonus requires 6 fresh referrals.
- Every referral must like/follow on YouTube, Facebook, or Instagram and upload a screenshot.
- Weekly promotional bonus will be released every Wednesday based on valid referrals.
- After 30 days or upon promotional bonus completion, the registered ID will automatically close.
- No extension or compensation will be given if referral goals are not completed.
- Re-registration for Hanuman Chalisa within 7 days is eligible for a ₹100 discount (applies to unlimited IDs).
- Aadhaar number is mandatory for re-registration verification for Hanuman Chalisa.
- A monthly physical Ekadash Hanuman Chalisa Path will be conducted.
- This program is spiritual in nature and not an investment or income scheme.

- 4th Referral ₹300
- 5th Referral ₹350
- 6th Referral ₹400

**Total Possible Bonus - ₹1500** (if completed within 30 days)

All promotional activities shall remain limited strictly to spiritual experiences. Eligibility for receiving promotional bonuses requires that the referred individual must subscribe, follow, and engage with all official social media platforms of "Kashtmukti09"—including YouTube, Facebook, Instagram, Telegram, WhatsApp, X (formerly Twitter), and any other platforms designated by the organization in the future. The organization reserves the unilateral right to verify such digital engagement through relevant analytics, records, or available digital data. Any failure, omission, or non-compliance in meeting these requirements shall automatically render the referral ineligible for any promotional bonus. The organization retains full, irrevocable, and unilateral authority to suspend, modify, alter, limit, or completely discontinue the promotional bonus system or any of its associated rules, processes, or benefits at any time, without prior notice, explanation, or liability. No participant, third party, or entity shall possess any legal claim, expectation, entitlement, or right to such bonuses, as they are solely symbolic acknowledgments and not income-based rights.
